RESOLUTION REQUESTING THE HON. SENATOR LOREN LEGARDA-LEVISTE, FOR HER ASSISTANCE IN ALLOCATING FUNDS FOR THE DEVELOPMENT OF THE PARAISO-NI-JUAN AS A BEACH TOURIST SPOT IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the Municipality of Narvacan offers potential tourist spots, it, being one of the towns in Northern Luzon discovered by the Spaniards ;

WHEREAS, the Municipality of Narvacan prides itself of a coastal shore dotted along the national highway that is a potential tourist attraction when fully developed;

WHEREAS, the "*Paraiso-ni-Juan*" is a beach haven that can be considered as the French Riviera of the North, situated along the national highway going to the historic Vigan City;

WHEREAS, a very strong feature of the "*Paraiso-ni-Juan*" is the *Immagamang*, a huge rock that prominently stands some 400 meters from the shoreline;

WHEREAS, the *Immagamang* has in imposing lifesize statue of the Virgin Mary that is frequented by beachgoers;

WHEREAS, there is no convenient access was to the *Immagamang* so that visitors have to pass through the rocky waters to reach the *Immagamang*, thus posing dangers to these visitors;




RESOLVED FURTHER that a copy of this Resolution be forwarded to the Hon. Senator LOREN LEGARDA-LEVISTE for her information and approval.
