RESOLUTION REQUESTING FOR THE APPROVAL OF THE CASANA COMMUNAL IRRIGATION SYSTEM UNDER THE DAR-ADB-ARC PROJECT IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the Municipality of Narvacan, Ilocos Sur is a recipient of the DAR-ADB ARC PROJECT through the CASANA Road Project which constructed farm-to-market road network spanning three barangays namely: Cagayugan, San Antonio and Nanguneg;

WHEREAS, the CASANA Road Project provides significant impact on the economy of the municipality particularly to the residents of the three barangays as commercial activities are enhanced;

WHERAS, the Municipal Administration has signified its intention to participate in the availment of sub-projects under the same DAR-ADB-ARC Project, availing thereof funding for the CASANA COMMUNAL IRRIGATION SYSTEM project;

WHEREAS, the Municipal Administration hereby authorizes the MDF-DOF to intercept the release of IRA equivalent to the amount due to MDF in the event the grant portion of the sub-project is converted into loan;

WHEREAS, the Municipal Council is appropriating the amount of Five Million Pesos (P5M) as equity allocation to be sourced partly from the 20% Municipal Development Fund and partly from the RA 7171 congressional share of Congressman Eric Singson;

WHEREAS, the Municipal Administration is committed to shoulder the cost of operation and maintenance of the project;

WHEREAS, the members of the Municipal Council are hereby authorizing the Municipal Mayor, Hon. Charito S. Zaragoza, to enter into a Memorandum of Agreement with the DAR-ADB and sign Special Power of Attorney relative to the CASANA Communal Irrigation System Project;

NOW THEREFORE, on motion duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED to pass this resolution REQUESTING FOR THE APPROVAL OF THE CASANA COMMUNAL IRRIGATION SYSTEM UNDER THE DAR-ADB-ARC PROJECT IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

RESOLVED FINALLY that this resolution be forwarded to the DAR-ADB to manifest willingness and capability of the Municipality of Narvacan, Ilocos Sur to undertake the CASANA Communal Irrigation System Project.
