A RESOLUTION REQUIRING ORGANIZERS OF ALL MEDICAL MISSIONS TO COORDINATE WITH AND TO SECURE THE APPROVAL OF THE LOCAL CHIEF EXECUTIVE UPON THE RECOMMENDATION OF THE MUNICIPAL HEALTH OFFICE FOR ANY PROGRAM OR ACTIVITY INVOLVING MEDICAL OR DENTAL SERVICES AND/OR SURGICAL OPERATIONS TO BE CONDUCTED WITHIN THE JURISDICTION OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the Department of Health has emphasized the need to regulate the conduct of medical missions to protect the public from unscrupulous individuals who are otherwise engaged in illegal practice of medicine;

WHEREAS, medical missions are primarily intended as outreach programs for humanitarian and non-profit purposes for the benefit of people who have limited or no means to pay;

WHEREAS, the Municipal Government of Narvacan is strongly committed to promoting the health and well-being of all its constituents and in providing affordable and accessible quality health care services on their behalf;


NOW THEREFORE, on motion duly seconded by the body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Office of the Sangguniang Bayan of Narvacan, Ilocos Sur to require organizers of all medical missions to coordinate with and to first secure the approval of the Local Chief Executive upon the recommendation of the Municipal Health Office prior to the conduct of the Medical Mission within the jurisdiction of the Municipality of Narvacan, Ilocos Sur involving any program or activity where medical or dental services are to be rendered, or where surgical procedures are to be performed.




