RESOLUTION REVISING AND APPROVING THE COMPREHENSIVE LAND USE PLAN OF THE MUNICIPALITY OF NARVACAN SUBJECT TO THE INDORSEMENT BY THE PROVINCIAL LAND USE COMMITTEE AND THE REGIONAL DEVELOPMENT COUNCIL THROUGH THE RDC EXECUTIVE COMMITTEE TO THE HOUSING AND LAND USE REGULATORY BOARD

WHEREAS, the people of the Municipality of Narvacan having worked together to evolve a guide which will direct their collective efforts and the use of their scarce resources to secure a better quality of life;

WHEREAS, the town plan having been submitted to the Sangguniang Bayan, and considering the comments and recommendations of the Regional Technical Review Committee and the general public through the public hearing/consultation, finds the same to be an effective instrument to attain the development goals and objectives of the municipality;

WHEREAS, Letter of Instruction No. 729 and Local Government Code of the Philippines requires that all local governments are required to submit their land use plans, zoning ordinances, enforcement systems and procedures for review and ratification,

BE IT RESOLVED AS IT IS HEREBY RESOLVED THAT:

SECTION 1. The Comprehensive Land Use Plan is hereby adopted and approved as the development plan of the Municipality of Narvacan.

SECTION 2. The Municipal Development Council/Staff shall conduct a periodic review of the plan and submit proposed changes to the Sangguniang Bayan through the Office of the Mayor for consideration and approval.


SECTION 3. All municipal departments and offices gear their programs, projects and activities in accordance with the plan.

SECTION 4. All national agencies and private entities generating program, projects or conducting activities in the municipality over which the municipal government have no control are enjoined to seriously consider the objectives of the plan, its proposed programs, policies and projects in developing their future programs, projects and activities.


RESOLVED FURTHER to submit copies of this plan to the Provincial Land Use Committee, Housing and Land Use Regulatory Board.




