
WHEREAS, the construction cost of said project is estimated to be **Twelve Million Five Hundred Thousand Pesos (12,500,000.00)**;

RESOLVED FINALLY, that copies of this Resolution be furnished to all persons and parties concerned for their information and appropriate action.


