RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY BENIGNO SIMEON AQUINO III, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES THROUGH HON. FLORENCIO B. ABAD, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT FUNDING ALLOCATION FOR THE CONSTRUCTION OF FLOOD CONTROL PROJECTS/SEAWALL AT BARANGAY PANTOC, NARVACAN, ILOCOS SUR

WHEREAS, the Municipality of Narvacan hogged the headlines several times due to the devastating perennial typhoons with incessant rainfall that brought about unprecedented flooding/storm surge causing enormous soil erosion along the coastal barangays particularly Barangay Pantoc;

WHEREAS, soil erosions are so intense that residential houses are being washed away every year leaving several families homeless and adversely affecting their sources of livelihoods and economic activities;

WHEREAS, in order to avert further damage to properties and to prevent/control once and for all this perennial problem (continuous soil erosion), immediate construction of Flood Control Structure is badly needed;

WHEREAS, the construction cost of said project (Phase I) is estimated to be **Twenty Million Pesos (P20,000,000.00)**;


WHEREAS, this goal, however, is constrained by financial limitations as the Municipal Administration depends on financial assistance from the National Government that is ever supportive of our needs;

NOW THEREFORE, on motion duly seconded by the body, be it resolved as it is hereby resolved by the Sanguniang Bayan of Narvacan, Ilocos Sur to request his Excellency Benigno Simeon Aquino III, President of the Republic of the Philippines thru Honorable Florencio Abad, Secretary, Department of Budget and Management (DBM) to allocate funds for the Construction of said Flood Control Structure Project;
