ABAD, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT FUNDING ALLOCATION FOR THE CONSTRUCTION OF FARM TO MARKET ROAD, BRGY SAN PABLO-DASAY, NARVACAN, ILOCOS SUR
