ABAD, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT FUNDING ALLOCATION FOR THE CONSTRUCTION OF FARM TO MARKET ROAD, BRGY SAN CAGAYUNGAN, SITIO SINGAT DASAY-SUCOC, NARVACAN, ILOCOS SUR


WHEREAS, the construction cost of said project is estimated to be **Fourteen Million Pesos (14,000,000.00)**;






