RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY BENIGNO SIMEON AQUINO III, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES THROUGH HON. FLORENCIO B. ABAD, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT FUNDING ALLOCATION FOR THE CONSTRUCTION OF FARM TO MARKET ROAD, BRGY ABUOR-DINALAOAN, NARVACAN, ILOCOS SUR

WHEREAS, the Municipal Administration has placed on top of its development agenda the CONCRETING OF FARM TO MARKET ROAD at this municipality;

WHEREAS, the construction cost of said project is estimated to be Twelve Million Five Hundred Thousand Pesos (12,500,000.00);
