RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY BENIGNO SIMEON AQUINO III, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES THROUGH HON. FLORENCIO B. ABAD, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT FUNDING ALLOCATION FOR THE CONSTRUCTION OF FARM TO MARKET ROAD, BRGY LANIPAO, NARVACAN, ILOCOS SUR

WHEREAS, the Municipal Administration has placed on top of its development agenda the CONCRETING OF FARM TO MARKET ROAD at this municipality;

WHEREAS, this goal, however is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government;
