ABAD, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT FUNDING ALLOCATION FOR THE CONSTRUCTION OF FARM TO MARKET ROAD, BRGY LANIPAO, NARVACAN, ILOCOS SUR


WHEREAS, the construction cost of said project is estimated to be **Twelve Million Five Hundred Thousand Pesos (12,500,000.00)**;
