**RESOLUTION AUTHORIZING THE HONORABLE ZURIEL S. ZARAGOZA, MUNICIPAL MAYOR, NARVACAN, ILOCOS SUR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE AGRIPINOY TOBACCO FARMERS FOOD PROCESSING PLANT AND TRADING CENTER (AGRIPINOY) FOR THE PURPOSE SPECIFIED HEREIN**

**WHEREAS**, the Agripinoy Tobacco Farmers Food Processing Plant and Trading Center (AGRIPINOY) proposes to establish a butchering/slaughtering school to equip tobacco farmers' dependents with the knowledge and skills in modern abattoir operations;

**WHEREAS**, the training school needs to be accredited by the Technical Education and Skills Development Authority (TESDA) so that the trainees will be issued National Certificate II (NC II) in Slaughtering Operations as a license for better employment and business opportunities;

**WHEREAS**, one of the requirements for accreditation is the provision of support services/facilities for the trainees such as health/medical services, sports development, library services, and abattoir;

**WHEREAS**, AGRIPINOY requested the Local Government Unit of Narvacan to allow the professors/instructors and students/trainees to access or use its facilities such as the Rural Health Unit and abattoir for emergency cases and for demonstration activities;


**WHEREAS**, the LGU of Narvacan has manifested its willingness to give access and allow the professors/instructors and students of the AGRIPINOY's butchering/slaughtering school to use the aforesaid facilities, free of charge, subject to the terms and conditions as provided under the Memorandum of Agreement between the LGU of Narvacan and AGRIPINOY;

**NOW THEREFORE**, the Sangguniang Bayan of Narvacan, Ilocos Sur in session assembled and on motion duly seconded, **RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Honorable Zuriel S. Zaragoza, Municipal Mayor, Narvacan, Ilocos Sur to enter into a Memorandum of Agreement (MOA) with the Agripinoy Tobacco Farmers Food Processing Plant and Trading Center (AGRIPINOY) for the purpose specified herein;

**RESOLVED FURTHER** that a copy of this Resolution be forwarded to AGRIPINOY, represented by its Project Manager, **MS. MINERVA P. MIZAL** to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the Memorandum of Agreement (MOA).
