RESOLUTION GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, HONORABLE ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL HOUSING AUTHORITY (NHA) REPRESENTED BY ATTY. CHITO M. CRUZ, GENERAL MANAGER IN THE IMPLEMENTATION OF THE HOUSING MATERIALS ASSISTANCE PROGRAM IN THE MUNICIPALITY

WHEREAS, Section 22, paragraph (c) of Republic Act 7160, otherwise known as the Local Government Code of 1991, expressly provides that:

"Unless otherwise provided in this code, no contract may be entered into by the Local government Unit without prior authorization by the Sangguniang concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipality or barangay hall."

WHEREAS, it is also stated under Section 444, par. (b), sub - par. (1), (vi), that:

"The Municipal Local Chief Executive shall upon authorization by the Sangguniang Bayan, represent the Municipality in all its business transaction and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

WHEREAS, the National Housing Authority (NHA), a government owned and controlled corporation is the sole government agency engaged in direct housing production mandated to address the housing needs of the low and marginal income families pursuant to Executive Order Number 90;

WHEREAS, the beneficiaries of the Housing Materials Assistance Program are the low or marginal - income families whose houses are partially or totally damaged by calamities and who are included in the Official Masterlist of Families Eligible for the said program as certified by the Municipal Social Welfare and Development Officer;


WHEREAS, this Body is optimistic that the benefits to be derived from the implementation of the said noble project will redound to the general welfare of all concerned at this local level as embodied in the provisions of Section 16 (General Welfare Clause) of the Local Government code of 1991.

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to authorize the Municipal Mayor, **Honorable Zuriel S. Zaragoza**, to enter into a Memorandum of Agreement with the National Housing Authority (NHA) represented by Atty. Chito M. Cruz, General Manager in the implementation of the Housing Materials Assistance Program in the municipality.

RESOLVED FINALLY to transmit copies of this Municipal Resolution to the Local Chief Executive, Zuriel S. Zaragoza, and to Atty. Chito M. Cruz, General Manager, National Housing Authority, Elliptical Road, Diliman, Quezon City and to all authorities concerned for their information.
