## RESOLUTION NO. 20 Series of 2015

REQUESTING FOR THE IMMEDIATE DEMOLITION OF THE NARVACAN ARC LOCATED AT NANGUNEG, NARVACAN, ILOCOS SUR AND APPROPRIATING FUNDS FOR ITS RECONSTRUCTION

**WHEREAS**, the Municipality of Narvacan aims to promote public safety to all motorists traveling along the National Highway of Narvacan, Ilocos Sur;

**WHEREAS**, the Narvacan Arc poses a threat to the lives of motorists due to its nearness/proximity to the national road, for which some drivers miscalculate the distance especially during the night;

**WHEREAS,** there is a clamor that this arc be demolished and be reconstructed a little further from the national road especially at this point in time that the road widening is on-going;

**WHEREAS,** the PNP-MPS of Santa Maria provided its Police Blotter Report that a grave vehicular accident occurred on February 8, 2015 at the Narvacan Arc located along the National Highway, where one died on the spot while the other passengers suffered injuries;

**WHEREAS**, the DPWH District Engineer wrote a letter to Mayor Zuriel S. Zaragoza reminding him that the Narvacan Welcome Arc situated in Nanguneg is affected by their road widening project, with an attached copy of DPWH Department Order No. 73, Series of 2014 titled "Prohibited Uses Within the Right-of-Way of National Roads";

**NOW, THEREFORE**, on motion of SBM Rosalinda Cabanilla, duly seconded by SBM Teofilo Cabreros hereby:

**RESOLVES AS IT IS HEREBY RESOLVED** that the Narvacan Arc situated at Barangay Nanguneg, be demolished and be reconstructed a distance of at least ten (10) meters further from the center of the national road, both sides and to allocate funds for its reconstruction;

**RESOLVED** further that this Resolution be submitted to Honorable Zuriel S. Zaragoza for his consideration and approval, with the attached Program of Work as estimated by the Municipal Engineer; and that a copy of this Resolution should also be forwarded to the DPWH for their coordination in carrying out the demolition/reconstruction of the Narvacan Arc;

**RESOLVED FINALLY** the allocation of funds for the project based on the estimate for its demolition and another for its reconstruction be submitted by the Municipal Engineer for the immediate construction thereof.
