RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY BENIGNO SIMEON AQUINO III, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES THROUGH HON. PAQUITO N. OCHOA, JR., EXECUTIVE SECRETARY, MALACAÑANG PALACE, MANILA, TO ENDORSE TO HON. FLORENCIO B. ABAD, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT FUNDING ALLOCATION FOR THE CONSTRUCTION OF FLOOD CONTROL PROJECTS IN THE MUNICIPALITY OF NARVACAN

WHEREAS, Narvacan a Second Class Municipality in the Province of Ilocos Sur is composed of 34 Barangays;

WHEREAS, the Philippines hogged the headlines several times due to the great catastrophe of typhoons such as Mario, Glenda and others, which mainly caused by the alarming and intensifying phenomenon of climate change; devastating perennial typhoons with incessant rainfall had brought about unprecedented flooding that caused enormous damages to agriculture, establishments, and properties of people;

WHEREAS, due to these calamities, it is imperative that the municipality reinforces its infrastructure to counter the effects of future phenomenon so that people's lives, community's properties, livelihood and economic activity shall be preserved and not affected adversely;

WHEREAS, feasibility studies were conducted, consultations, technical researches and site validations, several proposed engineering interventions in mitigation measures were recommended for immediate implementation such construction of flood control projects in various barangays of the municipality to minimize and control the flooding and consequently protect large tracts of farmlands from further destruction;

WHEREAS, the construction and/or rehabilitation of the aforesaid projects have an estimated project cost of Three Hundred Million Pesos (P300,000,000.00) as indicated in the attachment Program of Works provided by the Municipal Engineering Office;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Bayan of Narvacan, Ilocos Sur to request His Excellency Benigno Simeon Aquino III, President of the Republic of the Philippines through Hon. Paquito N. Ochoa Jr., Executive Secretary, Malacañang Palace, Manila, to endorse Hon Florencio B. Abad, Secretary, Department of Budget and Management (DBM) to grant funding allocation for the construction of flood control projects;


RESOLVE FINALLY, that copies of this resolution be furnished to all persons and parties concerned for their information and appropriate action.




