RESOLUTION NO. 02 Series of 2015

RESOLUTION AUTHORIZING THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR TO OPEN A NEW ACCOUNT FOR THE IRRIGATION SUPPORT PROJECT FOR SMALL TOBACCO FARMERS (ISPSTF) FUND WITH THE LAND BANK OF THE PHILIPPINES—NARVACAN BRANCH AND EMPOWERING THE HONORABLE ZURIEL S. ZARAGOZA, MUNICIPAL MAYOR AND MRS. ZENAIDA C. SALANG, OIC MUNICIPAL TREASURER — AS OFFICIAL SIGNATORIES

WHEREAS, the National Tobacco Administration has pursued under its Integrated Farming and Other Income Generating Activities Project (IFOIGAP), an Irrigation Support Project for Small Tobacco Farmers, in support of the Market-Driven Quality Production and Food Sufficiency Program of the Government, with funding support from the DBM, from the NTA's Tobacco Fund/Special Account in the General Fund (SAGF 151),

WHEREAS, the Local Government Code of 1991 (RA 7160) provides that the Local Government Units (LGUs) shall also exercise other powers and discharge such other functions and responsibilities that are necessary, appropriate or incidental to efficient and effective provision of the basic facilities and services, that include among others, on agriculture, barangay irrigaton systems, soils and water utilization and conservation projects; and on infrastructure, maintenance and rehabilitation of small water impounding projects, rainwater collector and watersupply systems and spring development;

WHEREAS, under the Magna Carta for Small Farmers (RA 7607), the government encourages small farmers to join or form irrigator's associations that will spearhead the construction of irrigation systems and promote participation of farmers that will develop their capabilities to eventually assume operation and maintenance of irrigation systems;

WHEREAS, the NTA, Local Government Unit of Narvacan and Farmers Association of Narvacan desire to embark collectively in the implementation of the Irrigation Support Project for Small Trobacco Farmers (ISPSTF);

WHEREAS, it is necessary to open a new account with the Land Bank of the Philippines–Narvacan Branch wherein the ISPSTF Fund shall be credited;

WHEREAS, the **Honorable Zuriel S. Zaragoza**, Municipal Mayor and **Mrs. Zenaida C. Salang**, Municipal Treasurer—OIC shall be the official signatories in all financial transactions concerning the ISPSTF Fund entered into by the Local Government Unit of Narvacan, Ilocos Sur and the National Tobacco Administration;

NOW THEREFORE, the Sangguniang Bayan of Narvacan, Ilocos Sur, in session assembled and on motion duly seconded, **RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Local Government Unit of Narvacan, Ilocos Sur to open a new account for the Irrigation Support Project for Small Tobacco Farmers (ISPSTF) Fund with the Land Bank of the Philippines – Narvacan Branch and empowering the Honorable Zuriel S. Zaragoza, Municipal Mayor and Mrs. Zenaida C. Salang, Municipal Treasurer—OIC as official signatories;

RESOLVED FURTHER that this Resolution be effected immediately upon approval by the Sangguniang Bayan;

RESOLVED FINALLY that copies of this Resolution be forwarded to all agencies and parties concerned for their information and appropriate actions.
