**WHEREAS**, the Municipal Administration urgently needs development funds to meet the urgency of the said project in order to protect Barangay San Pedro in the face of widespread coastal and environmental degradation;


**WHEREAS**, the Sangguniang Bayan of Narvacan, Ilocos Sur always trusts in the sincere concern of **Senator Francis "Chiz" Escudero** in sharing allocation to finance vital countryside infrastructure programs;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request the **Honorable Francis "Chiz" Escudero**, Senator, Republic of the Philippines, for his financial assistance in the amount of Five Million Pesos (P5M) for the rehabilitation/repair of the seawall in Barangay San Pedro this municipality;




