RESOLUTION SIGNIFYING THE LGU'S INTEREST TO PARTICIPATE IN THE COUNTER-PARTING SCHEME PROGRAM OF THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (NDRRMC)

WHEREAS, the Municipality of Narvacan, Ilocos Sur is severely devastated during the rampage caused by Typhoon Pepeng and aggravated by Typhoon Juan;

WHEREAS, many farm-to-market roads, seawalls and other infrastructure projects have been destroyed due to the two typhoons;

WHEREAS, the National Disaster Risk Reduction and Management Council (NDRRMC) collaborates with Local Government Units to assist in the implementation of rehabilitation services such as infrastructure projects;

WHEREAS, the Local Government Unit of Narvacan, Ilocos Sur signifies to be a conduit in implementing infrastructure projects like repair/rehabilitation of farm-to-market roads and seawalls which can serve a greater number of its constituents especially the lowly farmers and fisherfolks;

WHEREAS, when fully realized, the said projects will provide better and faster means of transporting farm products to the market and will protect the coastal barangays from damage and flood waters coming from the sea;

WHEREAS, due to the limited calamity fund, the municipal government is seeking the financial support of the Department of National Defense through the National Disaster Risk Reduction and Management Council to repair/rehabilitate the various farm-to-market roads, seawalls and other infrastructure projects in the municipality;

WHEREAS, in the implementation of the said project, the LGU of Narvacan shall provide its counterpart fund amounting to 40% of the total fund that the NDRRMC shall grant, and whatever amount the NDRRMC shall provide, the LGU will complete the project to be implemented;

NOW THEREFORE, on motion of SBM Eliseo D. Cabradilla, Chair, Committee on Infrastructure and Public Works and Slaughterhouse, seconded by SBM Carlito T. Corrales, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to signify the LGU's interest to participate in the counter-parting scheme program of the National Disaster Risk Reduction and Management Council (NDRRMC);

RESOLVED FURTHER that a copy of this Resolution be forwarded to the National Disaster Risk Reduction and Management Council, represented by its Chairman, the **Honorable Voltaire Gazmin**, Secretary, Department of National Defense, for his information and appropriate action.
