**RESOLUTION EARNESTLY REQUESTING THE HONORABLE SENATOR JUAN MIGUEL F. ZUBIRI, SENATOR, REPUBLIC OF THE PHILIPPINES, FOR HIS FINANCIAL ASSISTANCE IN THE AMOUNT OF FIVE MILLION PESOS (P5M) FOR THE REHABILITATION/REPAIR OF THE SEAWALL IN BARANGAY SAN PEDRO THIS MUNICIPALITY**

**WHEREAS**, the Municipal Administration has placed on top of its priority development agenda the rehabilitation/repair of the seawall in Barangay San Pedro which was damaged by the storm surge caused by Typhoon Juan;

**WHEREAS**, the rehabilitation/repair of the said seawall is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government that is ever supportive of our development efforts;

**WHEREAS**, the Municipal Administration urgently needs development funds to meet the urgency of the said project in order to protect Barangay San Pedro in the face of widespread coastal and environmental degradation;

**WHEREAS**, the Sangguniang Bayan of Narvacan, Ilocos Sur always trusts in the sincere concern of **Senator Juan Miguel F. Zubiri** in sharing allocation to finance vital countryside infrastructure programs;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request the **Honorable Juan Miguel F. Zubiri**, Senator, Republic of the Philippines, for his financial assistance in the amount of Five Million Pesos (P5M) for the rehabilitation/repair of the seawall in Barangay San Pedro this municipality;
