A RESOLUTION REQUESTING HIS EXCELLENCY BENIGNO SIMEON C. AQUINO III, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, THROUGH HON. FLORENCIO "BUTCH" ABAD, SECRETARY, DEPARTMENT OF BUDGET & MANAGEMENT, FOR THE RELEASE AND UTILIZATION OF FUNDS CHARGEABLE AGAINST THE LOCAL GOVERNMENT SUPPORT FUND FOR FISCAL YEAR 2014 IN THE AMOUNT OF FIFTEEN MILLION PESOS (P15,000,000.00) FOR THE REHABILITATION OF BRIDGES, IMPROVEMENT OF FARM-TO-MARKET ROADS, CONCRETING OF BARANGAY ROADS, COMPLETION OF MULTI-PURPOSE BUILDING, IMPROVEMENT OF LADRILLO ROAD AND IMPROVEMENT OF MUNICIPAL SLAUGHTERHOUSE IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, DBM Local Budget Circular No. 105 requires the submission of an SB Resolution and List of Projects as prerequisites for the release of funds chargeable against the Local Government Support Fund (LGSF) for FY 2014;

WHEREAS, the Municipal Government of Narvacan is strongly committed to our objective of bringing about the renewed development and prosperity of our constituents through the efficient delivery of basic goods and services, which include the construction, completion and improvement of various infrastructure projects in our municipality;

WHEREAS, our municipality's general welfare goals are only achievable with the release of much-needed funds from the LGSF to finance priority programs and projects of LGU-Narvacan, to be identified herein;

WHEREAS, the Local Government Unit of Narvacan has determined that the total estimated cost of the List of Priority Projects stands at Fifteen Million Pesos (P15,000,000.00);

WHEREAS, the implementation of these priority infrastructure projects will surely uplift the socio-economic status of our town, provide for the immediate needs of the community, and attain the overall improvement in the living standards of every Narvacaneo;

NOW THEREFORE, on motion duly seconded by the body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Office of the Sangguniang Bayan of Narvacan, Ilocos Sur to request His Excellency Benigno Simeon C. Aquino III, President of the Republic of the Philippines, through Hon. Florencio "Butch" Abad, Secretary, Department of Budget & Management, for the release and utilization of funds chargeable against the

Local Government Support Fund for Fiscal Year 2014 in the amount of Fifteen Million Pesos (P15,000,000.00) for the rehabilitation of bridges, improvement of farm-to-market roads, and concreting of barangay roads in the Municipality of Narvacan, Ilocos Sur, as follows:


