**RESOLUTION AUTHORIZING THE HONORABLE ZURIEL S. ZARAGOZA, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT I FOR THE CONSTRUCTION AND/OR REHABILITATION/IMPROVEMENT OF CAGAYUNGAN FARM TO MARKET ROAD THIS MUNICIPALITY**

**WHEREAS**, the Department of Agriculture (DA) is providing integrated services to ensure the increase in farm productivity as well as real-income of small farmers;

**WHEREAS**, the construction and/or rehabilitation/improvement of Farm-to-Market Roads (FMR) is a project for agricultural development and production;

**WHEREAS**, the Local Government Code of 1991 allows the national agency to complement national funded requests, facilities, programs and services jointly or with the assistance of the local government units;

**WHEREAS**, the Local Government Unit of Narvacan has identified the site and requested the release of fund for the construction and/or rehabilitation/improvement of Cagayungan Farm-to-Market Road;

**WHEREAS**, the available fund for the construction and/or improvement/rehabilitation of Cagayungan Farm-to-Market Road has a total amount of FIVE MILLION PESOS (P5,000,000.00);


