RESOLUTION AUTHORIZING THE HONORABLE ZURIEL S. ZARAGOZA, MUNICIPAL MAYOR, NARVACAN, ILOCOS SUR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) FOR THE IMPLEMENTATION OF EMERGENCY EMPLOYMENT PROGRAM AND PROVISION OF LIVELIHOOD TRAININGS AND STARTER KITS

WHEREAS, to alleviate affected sectors from the impact of typhoon damages, the national government thru the Department of Labor and Employment (DOLE) launched the Emergency Employment Program and Provision of Livelihood Trainings and Starter Kits to be implemented by local government units;

WHEREAS, the program aims to provide out-of-school youth, long term unemployed poor, displaced workers, and workers in flood/slide prone areas with short term wage employment in various community work projects as immediate source of income for them and their families;

WHEREAS, the Local Government of Narvacan, Ilocos Sur shall repair/restore and even improve various barangay roads; beneficiaries shall be fifty (50) workers from affected barangays: Santa Lucia, San Jose.

WHEREAS, as stipulated in the draft Memorandum of Agreement (MOA) DOLE shall provide fund assistance to the Local Government Unit in the form of wages for 50 workers and in the form of trainings and starter kits for twenty five (25) disadvantaged workers while the local government shall provide equity of at least twenty percent (20%) of the total project cost;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to authorize the Honorable Zuriel S. Zaragoza, Municipal Mayor, Narvacan, Ilocos Sur to enter into a Memorandum of Agreement (MOA) with the Department of Labor and Employment (DOLE) for the implementation of Emergency Employment Program and Provision of Livelihood Trainings and Starter Kits;

RESOLVED FURTHER to furnish copies of this Resolution to the Department of Labor and Employment (DOLE) Region I, San Fernando City, La Union and all authorities concerned for their information and immediate appropriate action.


