RESOLUTION EARNESTLY REQUESTING THE HONORABLE VOLTAIRE T. GAZMIN, SECRETARY, DEPARTMENT OF NATIONAL DEFENSE AND CHAIRMAN, NATIONAL DISASTER COORDINATING COUNCIL, FOR FINANCIAL ASSISTANCE FOR THE RESTORATION OF DAMAGED FLOOD CONTROL STRUCTURES IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR BROUGHT ABOUT BY TYPHOON MARIO

WHEREAS, the Municipality of Narvacan, Ilocos Sur has been declared under a state of calamity due to the widespread damage and heavy flooding throughout the town caused by typhoon Mario;

WHEREAS, typhoon Mario proved to be one of the worst tropical storms to hit our municipality in many years despite PAG-ASA's announcement that only storm Signal No. 1 was raised as of September 19, 2014, friday evening;

WHEREAS, many far-flung areas in our town are still inaccessible and/or isolated due to floodwaters, uprooted trees and road obstructions. Numerous power transmission lines were also cut off and electrical posts were toppled, with electricity not yet restored in many areas;

WHEREAS, the flood control structures of the following barangays have been heavily damaged: San Pedro, Pantoc, Cagayungan, Rivadavia, Codoog, Ambulogan;

WHEREAS, the estimated damage to these infrastructures worth more than Thirty Five Million Pesos (P35,000,000.00)


WHEREAS, the immediate restoration of these flood control structures is necessary to mitigate the detrimental effects of heavy downpours in areas already affected by the recent typhoon;

NOW THEREFORE, on motion duly seconded by the body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request the **Honorable Voltaire T. Gazmin**, Secretary, Department of National Defense and Chairman, National Disaster Coordinating Council, for financial assistance in the amount of Thirty Five Million Pesos (P35,000,000.00) for the restoration of damaged flood control structures in the municipality of Narvacan, Ilocos Sur;

RESOLVED FINALLY that a copy of this Resolution be forwarded to the **Honorable Voltaire T. Gazmin** for his information and appropriate action.


