RESOLUTION EARNESTLY REQUESTING THE HON. ROGELIO SINGSON, SECRETARY, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) THRU ENGR. RODOLFO DION OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) OF THE 2ND DISTRICT OF ILOCOS SUR TO PROVIDE FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY FIVE MILLION PESOS (P35,000,000.00) FOR THE RECONSTRUCTION AND REHABILITATION OF INFRASTRUCTURES LIKE ROADS, BRIDGES AND SEAWALLS/FLOOD CONTROL STRUCTURES HEAVILY DAMAGED BY TYPHOON 'MARIO' IN THIS MUNICIPALITY

WHEREAS, the onslaught of typhoon 'Mario' accompanied by strong winds and torrential rains has brought severe damages to infrastructures like roads, bridges, flood control structures and sea walls in our municipality;

WHEREAS, the Sangguniang Bayan with the approval of the Municipal Mayor passed a Resolution declaring the Municipality of Narvacan under a **`STATE OF CALAMITY'**;

WHEREAS, there is an imperative need to finance rehabilitation efforts including the reconstruction of destroyed roads, bridges and flood control structures in the barangays declared under critical condition during the height of typhoon 'Mario' including the seawalls along the coastal barangays;

WHEREAS, the realization of these projects is immediate as the reconstruction and rehabilitation of the said roads, bridges and seawalls is vital to the day to day living condition of the people in this municipality;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to earnestly request **Hon. Rogelio Singson,** Secretary, Department of Public Works and Highways (DPWH) to provide financial assistance in the amount of **P35,000,000.00** for the reconstruction and rehabilitation of roads, bridges and seawalls in the Municipality of Narvacan, Ilocos Sur;

RESOLVED FURTHER that a copy of this Resolution be forwarded to **Hon. Rogelio Singson** for his information and appropriate action.
