**WHEREAS**, the onslaught of typhoon 'Mario' accompanied by strong winds and torrential rains has brought severe damage to crops, livestock and fisheries in the Municipality of Narvacan;

**WHEREAS**, the Sangguniang bayan with the approval of the Municipal Mayor has passed a Resolution declaring the Municipality of Narvacan under a '**STATE OF CALAMITY**';

**WHEREAS**, there is an imperative need to finance rehabilitation efforts including the replanting of crops, replacement of livestock, reconstruction and repair of fish cages and fishponds in the barangays heavily affected;

**WHEREAS**, the realization of these projects is immediate as the same is vital to replenish loss of agricultural products to sustain and even increase the economic viability of this municipality;


**WHEREAS**, the estimated damage is worth more than Forty Million Twenty Two Thousand Five Hundred Pesos (40,022,500.00);


**RESOLVED FURTHER** that a copy of this Resolution be forwarded to **Hon. Proceso Alcala** for his information and appropriate action.






