A RESOLUTION AUTHORIZING MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO FILE AN APPROPRIATE CASE IN COURT TO RESTRAIN/PROHIBIT THE CONSTRUCTION & OPERATION OF THE PROPOSED BARANGAY QUINARAYAN PRODUCT EXCHANGE AND SKILLS TRAINING CENTER PROJECT AT BRGY. QUINARAYAN, NARVACAN, ILOCOS SUR

WHEREAS, the Office of the Sangguniang Bayan issued Resolution No. 39, series of 2014 entitled a "Resolution Expressly Disallowing the Construction of the proposed Barangay Quinarayan Product Exchange and Skills Training Center Project at Brgy. Quinarayan, Narvacan, Ilocos Sur";

WHEREAS, SB Resolution No. 39 was served at the construction site on April 7, 2014 by Municipal Engineers Arsenio Car and Danny Cabatan accompanied by PO3 Benny L. Cabanas and PO3 Allan R. Amor of the PNP;

WHEREAS, in spite of the service of the SB resolution, construction of the project has continued to this very day, to the prejudice of the Municipal Government of Narvacan;

NOW THEREFORE, on motion duly seconded by the body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Office of the Sangguniang Bayan to authorize Municipal Mayor Zuriel S. Zaragoza to file an appropriate case in court to restrain/prohibit the construction and operation of the proposed Barangay Quinarayan Product Exchange and Skills Training Center Project at Brgy. Quinarayan, Narvacan, Ilocos Sur.
