RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE (DA) REGIONAL FIELD OFFICE FOR THE IMPLEMENTATION OF PROJECTS UNDER THE GRASSROOTS PARTICIPATORY BUDGETING PROGRAM

WHEREAS, through DBM-DILG-DSWD-NAPC Joint Memorandum Circular (JMC) No. 1, dated March 8, 2012, the Bottom-Up Planning and Budgeting (BUB) called as the Grassroots Participatory Budgeting (GPBP) was formally adopted as a strategy in pursuing the Millenium Development Goal (MDG) of reducing poverty, as well as the national government's goals of inclusive growth and poverty reduction, as indicated in the 2011-2016 Philippine Development Plan (PDP);

WHEREAS, the GPBP is also intended to make the planning and budgeting processes of both local and national governments more participatory through the genuine involvement of grassroots organizations and communities, and to strengthen the convergence of the delivery of national services in the community;

WHEREAS, the Department of Agriculture (DA) is among the 13 participating government agencies in the implementation of the GPBP;

WHEREAS, consistent with the objectives of the GPBP, and as stipulated in JMCs Nos. 1, 2, 3, and 4 and defining the guidelines and procedures in the implementation of the GPBP projects, the participating municipal LGUs shall implement the BUB/GPB projects, subject to the LGU eligibility requirements, among others;

WHEREAS, for FY 2014, the following projects proposed by the Local Government Unit of Narvacan have been approved for funding and implementation under the GPBP of the DA:
