RESOLUTION EXPRESSLY DISALLOWING THE CONSTRUCTION OF THE PROPOSED BARANGAY QUINARAYAN PRODUCT EXCHANGE AND SKILLS TRAINING CENTER PROJECT AT BRGY. QUINARAYAN, NARVACAN, ILOCOS SUR

WHEREAS, on February 17, 2014, the Sangguniang Bayan adopted by majority vote the Committee Report of the Committee on Public Enterprise, Trade and Industry on the "RESOLUTION ENDORSING THE PROJECT (BARANGAY QUINARAYAN PRODUCT EXCHANGE AND SKILLS TRAINING CENTER INCLUDING THE BARANGAY TALIPAPA) AT THE SAME TIME REQUESTING THE ENDORSEMENT OF THE SANGGUNIANG BAYAN OF NARVACAN, ILOCOS SUR";

WHEREAS, in the Committee Report, it was recommended that no sufficient basis or justification was found to endorse the proposed Product Exchange and Skills Training Center Project; hence, no endorsement or approval was issued by the Sangguniang Bayan to authorize the construction of the barangay *talipapa* project;

WHEREAS, an on-site inspection was conducted by Municipal Engineer Eleuterio G. Ines on March 17, 2014 where he discovered that construction for the project has resumed despite the lack of endorsement from the SB;

WHEREAS, the continued construction of the proposed project is made in total disregard to the decision of the SB in not granting approval to the request for endorsement from the barangay officials of Brgy. Quinarayan;

WHEREAS, the Sangguniang Bayan stands firm on their decision to disallow the proposed barangay *talipapa* and skills training center project, and to further express their recommendation in no uncertain terms;


NOW THEREFORE, on motion duly seconded by the body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Office of the Sangguniang Bayan to expressly disallow and stop the construction of the Barangay Quinarayan Product Exchange and Skills Training Center Project at Brgy. Quinarayan, Narvacan, Ilocos Sur.

RESOLVED FURTHER, that copies of this Resolution be furnished to Municipal Engineer Eleuterio G. Ines, to Brgy. Capt. Alexander Antolin and to the contractor, for their information and proper action.


RESOLVED FINALLY, that this Resolution shall take effect immediately.






