WHEREAS, this goal, however, is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government that is ever supportive of our development efforts;

WHEREAS, the Municipal Administration urgently needs development funds to finance the abovementioned project that needs the amount of thirty million pesos (P 30,000,000.00);
