### RESOLUTION NO. 21 Series of 2014

RESOLUTION APPROVING THE CONSTRUCTION OF A POULTRY FARM PROJECT OF THREE HUNDRED (300) HEADS IN BARANGAY SARMINGAN, NARVACAN, ILOCOS SUR

**WHEREAS,** Mr. Ron Loui Tanacio, a resident of Barangay Sarmingan, Narvacan, Ilocos Sur applied for a permit to construct a Poultry Farm Project on a parcel of land he owns located in the boundary of Sarmingan and Estancia;

**WHEREAS**, Barangay Sarmingan and Estancia issued a Memorandum of Agreement regarding the construction of the Poultry Farm;

**WHEREAS,** Mr. Tanacio intends to raise a maximum of three hundred (300) heads in said poultry farm and was able to secure a clearance from the Barangay Council of Sarmingan through a council resolution;

**WHEREAS,** SBM Edna C. Sanidad, the Committee Chairman on Health and Sanitation personally visited the area on said lot in barangay Sarmingan and noted that the distance of the lot from the nearest house is 600 meters;

**NOW, THEREFORE,** this August body in session hereby Resolves as it is hereby Resolved after reviewing the documents submitted by Mr. Tanacio to approve the request of Mr. Tanacio to construct his poutry farm project situated in barangay Sarmingan;

**RESOLVED FINALLY,** to furnish copies of this Resolution to the Municipal Health Office, Municipal Agriculture Office, the Barangay Council of Sarmingan and Mr. Tanacio himself for their information and reference.

## MEMORANDUM OF AGREEMENT

#### KNOW ALL MEN BY THESE PRESENTS:

This MEMORANDUM OF AGREEMENT is made, executed and entered into by and between:

BARANGAY ESTANCIA, NARVACAN, ILOCOS SUR, a local government unit created and existing under and by virtue of Philippine law, with principal office address at Estancia, Narvacan, Ilocos Sur, represented herein by Barangay Captain FERDINAND C. TACLA, hereinafter referred to as "BRGY. ESTANCIA";

#### -AND-

RON LOUI D. TANACIO, of legal age, single, and a resident of Sarmingan, Narvacan, Ilocos Sur, hereinafter referred to as the "APPLICANT".

#### WITNESSETH:

WHEREAS, BRGY. ESTANCIA is committed to ensuring the health and well-being of all barangay residents, promoting a healthy and well-balanced ecology and protecting the environment and natural resources, pursuant to the general welfare clause of the Local Government Code of 1991;

WHEREAS, the APPLICANT is the proprietor/owner of a proposed POULTRY PROJECT to be established/implemented at BRGY. ESTANCIA, upon the conformity of the barangay officials and with the approval of the Office of the Sangguniang Bayan of Narvacan, Ilocos Sur:

WHEREAS, the Office of the Sangguniang Bayan may require that buildings and the premises thereof and any land within the municipality be kept and maintained in a sanitary condition and may impose penalties for any violation thereof, or upon failure to comply with said requirement;

**NOW THEREFORE** for and in consideration of the foregoing premises and of the terms and conditions hereinafter set forth, the parties have mutually agreed as follows:

- 1. The APPLICANT shall maintain the cleanliness and sanitation of the Poultry Project in keeping with the pertinent provisions of the Implementing Rules and Regulations to Govern the Processing of Applications for Locational Clearance of Poultries, issued by the Housing and Land Use Regulatory Board;
- The APPLICANT hereby agrees to cause the closure of the Poultry Project upon petition of a majority of the residents of BRGY. ESTANCIA in case of noncompliance with the requirements set forth by Environmental Management Bureau (EMB), and upon order of the Department of Environment and Natural Resources (DENR);
- 3. That any concerned resident of BRGY. ESTANCIA may petition for the closure of the Poultry Project wherein the continued operation thereof may prove to be detrimental or hazardous to the health of the barangay residents.

IN WITNESS WHEREOF, the parties have caused this agreement to be executed by their respective officers, thereunto duly authorized at Narvacan, Ilocos Sur this \_\_\_\_ day of February 2014.
