RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE COCONUT AUTHORITY (PCA) FOR INCLUSION OF THE LOCAL GOVERNMENT UNIT OF NARVACAN IN THE COCONUT SEEDLINGS DISPERSAL PROJECT (CSDP)

WHEREAS, the Philippine Coconut Authority (PCA), the sole government agency mandated by law to oversee the development of the coconut industry in all aspects, is implementing the Coconut Seedlings Dispersal Project (CSDP);

WHEREAS, the CSDP intends, among others, to grant qualified coconut farmers and would-be coconut farmers coconut seedlings for planting and replanting in their coconut farms;

WHEREAS, the LGUs and CSOs including the private sector play crucial roles across the whole supply-value chain of the industry and by forging partnership with the PCA would help achieve production-market integration that would redound to the benefit of the small coconut farmers;


WHEREAS, the LGU of Narvacan, Ilocos Sur has signified its intention to be included in the program and is willing to offer 48.0 hectares of its land for coverage under coconut planting and replanting program;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor Zuriel S. Zaragoza to enter into a memorandum of agreement with the Philippine Coconut Authority (PCA) for inclusion of the Local Government Unit of Narvacan in the Coconut Seedlings Dispersal Project (CSDP);


RESOLVED FURTHER that a copy of this Resolution be forwarded to the Philippine Coconut Authority (PCA), represented by its Regional Manager III, **Domingo D. Frugal**, to manifest adherence of the Local Government Unit of Narvacan to its responsibilities stipulated in the Memorandum of Agreement (MOA).






