Zaragoza to enter into a contract of lease with the stallholders of the Uniform Food Stalls of the Narvacan Public Market which stipulates among others that the Lessee is bound to comply with the Uniform Food Stalls House Rules, and violations thereof entitles the Market Administration to issue reprimand or cause temporary closure as the case may be; while the Lessor warrants to forever defend the property/leased premises in favor of the Lessee, its successors and assign against all claims, including demands on suits that may be instituted against the Lessee, its successor and assign by whomsoever, judicially or extra judicially;

WHEREAS, the said Contract of Lease and any extension or renewal thereof shall be binding not only between the parties but also upon their respective successors, transferees and assigns;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize Mayor Zuriel S. Zaragoza to enter into a Contract of Lease with the stallholders of the Uniform Food Stalls of the Narvacan Public Market;
