RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY BENIGNO SIMEON C. AQUINO, PRESIDENT, REPUBLIC OF THE PHILIPPINES, TO PROVIDE FINANCIAL ASSISTANCE UNDER THE PRESIDENTIAL SOCIAL FUNDS IN THE AMOUNT OF TWENTY MILLION PESOS (P 20,000,000.00) FOR THE CONSTRUCTION / IMPROVEMENT OF FARM-TO-MARKET ROADS IN NARVACAN, ILOCOS SUR
