RESOLUTION EARNESTLY REQUESTING THE HONORABLE CRISTINO L. NAGUIAT, JR., CHAIRMAN AND CHIEF EXECUTIVE OFFICER, PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR), TO PROVIDE FINANCIAL ASSISTANCE IN THE AMOUNT OF TWELVE MILLION PESOS (P 12,000,000.00) FOR THE INSTALLATION OF 120 UNITS OF LED 120W STREETLIGHTS ALONG THE 3-KILOMETER SHORELINE BOULEVARD

WHEREAS, the Municipal Administration has come up with its Tourism Investment Plan which provides the framework for tourism development and wider economic venture in this municipality;

WHEREAS, the plan consists of novel approaches such as the development of the more than one (1) hectare Activity Area where the zipline, via ferrata, tourism office and other facilities shall be put up;

WHEREAS, the development of the Activity Area includes the putting up of 120 units of LED 120W streetlights along the 3-kilometer bay boulevard at 50 meter interval per post;

WHEREAS, the realization of the project is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government that is ever supportive of our development efforts;


