RESOLUTION ENDORSING THE SAN ESTEBAN-LAOAG 230 KV TRANSMISSION PROJECT (STAGE 2) OF THE NATIONAL GRID CORPORATION OF THE PHILIPPINES (NGCP)

WHEREAS, the Sangguniang Bayan of Narvacan received a letter from the National Grid Corporation of the Philippines (NGCP) requesting the August Body to enact a resolution endorsing the San Esteban-Laoag 230 KV Transmission Project (Stage 2) that will traverse portions of Barangays Sulvec, San Antonio, Paratong, Nanguneg, Margaay and Bantay Abot this municipality;

WHEREAS, the San Esteban-Laoag 230 KV Transmission Project (Stage 2) which aims to transmit the power generated by the proposed windfarms in Ilocos Norte, will strengthen the transmission corridor in the Ilocos area and at the same time comply with the single outage or N-1 contingency criterion required by the Philippine Grid Code;

WHEREAS, the project involves the construction of an approximately 120 km. long double-circuit 230 KV transmission line from NGCP's San Esteban Substation (S/S) in Ilocos Sur to its Laoag S/S in Ilocos Norte;

WHEREAS, the said project does not pose any danger or harm, thus, gaining conformity and endorsements of the aforementioned affected barangays;

WHEREAS, the Members of the Legislative Council, after careful deliberation, find no objection to and favorably endorses the construction of the project;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to endorse the San Esteban-Laoag 230 KV Transmission Project (Stage 2) of the National Grid Corporation of the Philippines (NGCP);

RESOLVED FURTHER, that copies of this Resolution be forwarded to all parties concerned for their information and appropriate actions.
