**RESOLUTION ALLOCATING FUNDS FOR MUNICIPAL DEVELOPMENT
PROJECTS IN THE AMOUNT OF FORTY MILLION NINE HUNDRED THIRTY
SEVEN THOUSAND TWO HUNDRED FOUR PESOS (P40,937,204.00)
REPRESENTING THE DIRECT SHARE OF THE MUNICIPALITY OF
NARVACAN FROM THE TOBACCO EXCISE TAX PURSUANT TO REPUBLIC
ACT 7171 FOR THE CALENDAR YEAR 2012**

WHEREAS, THE Municipal Administration has identified priority projects to sustain its development efforts thereby strengthening the economy of the municipality;

WHEREAS, the Members of the Sangguniang Bayan fully support the development agenda of the Municipal Administration;

WHEREUPON, after careful analysis and mature deliberations on the proposals presented, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to appropriate the amount of Forty Million Nine Hundred Thirty Seven Thousand Two Hundred Four Pesos (P40, 937, 204.00) representing the direct share of the Municipality of Narvacan from the tobacco excise tax pursuant to Republic Act 7171 for the Calendar Year 2012;

RESOLVED FURTHER, to enact the corresponding Appropriation Ordinance, to wit:

APPROPRIATION ORDINANCE NO. 2


Section 1. BE IT ENACTED BY THE MEMBERS OF THE SANGGUNIANG BAYAN to appropriate the amount of Forty Million Nine Hundred Thirty Seven Thousand Two Hundred Four Pesos (P40,937, 204.00) chargeable against the funds from Republic Act 7171 Municipal Share which is allotted for the following projects:
