RESOLUTION AUTHORIZING THE HONORABLE ZURIEL S. ZARAGOZA, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE FOR THE ESTABLISHMENT OF ORGANIC TRADING POST

WHEREAS, Republic Act 10068 otherwise known as Organic Agriculture Act of 2010, authored by Agriculture Secretary Proceso J. Alcala, was enacted to develop and promote organic agriculture in the Philippines;

WHEREAS, the Municipal Administration fully supports the National Organic Agriculture Program and has come up with its Municipal Organic Agriculture Development Plan and Budget;

WHEREAS, the Municipal Organic Agriculture Development Plan defines the framework, strategies and key activities/projects with indications of its key measures of the 2012-2016 program for the organic agriculture in the municipality;

WHEREAS, one key activity/project is the putting up of an Organic Trading Post (OTP) to market the organic produce of our farmers and accelerate the profitability and productivity of other organic farmers and small scale entrepreneurs;


