RESOLUTION ESTABLISHING AND DECLARING THE NORTHERN PART OF THE COASTAL AREA OF SULVEC, 5 HECTARES CORE ZONE AND 5 HECTARES BUFFER ZONE, AS MUNICIPAL FISH SANCTUARY

WHEREAS, the Municipal Administration has come up with its list of priority projects;

WHEREAS, one of these projects is the establishment of a fishery refuge or sanctuary to promote the integrated development of the fishery resources of the municipality;

WHEREAS, 15% of the northern part of the coastal area of Sulvec is applicable to be established as fish refuge or sanctuary;

WHEREAS, the Municipal Fisheries and Aquatic Resources Management Council (MFARMC) has approved the area to be developed into municipal fish sanctuary;


WHEREAS, the Municipal Fisheries and Aquatic Resources Management Council (MFARMC) shall cause the posting of a sign declaring the area as a fish sanctuary in a conspicuous place within the belowmentioned location for the public to see;

NOW THEREFORE, the Sangguniang Bayan of Narvacan, Ilocos Sur, in session assembled and on motion duly seconded, **RESOLVED AS IT IS HEREBY RESOLVED** to establish and declare the northern part of the coastal area of Sulvec, 5 hectares core zone and 5 hectares buffer zone, as municipal fish sanctuary;


