**RESOLUTION AFFIRMING THE COMMITMENT AND WILLINGNESS OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR AS PARTNER OF THE DEPARTMENT OF HEALTH (DOH) IN THE IMPLEMENTATION OF THE FAMILY PLANNING PROGRAM, NOW KNOWN AS THE CONTRACEPTIVE SELF-RELIANCE PROGRAM**

**WHEREAS**, the Philippine Constitution mandates that the state shall protect and promote the people's right to health and shall ultimately improve the people's quality of life;

**WHEREAS**, the Family Planning Program, now known as the Contraceptive Self-Reliance (CSR) Program, is an essential health program of the Government of the Philippines;

**WHEREAS**, the Philippine Government, through the Department of Health (DOH), formulated the Contraceptive Self-Reliance (CSR) Strategy, a set of measure assuring that supplies for family planning services are sufficient for the increasing number of users;

**WHEREAS**, the CSR Program needs the full and continued support and active involvement of the Local Government Unit of Narvacan, Ilocos Sur;

**NOW THEREFORE**, on motion of SBM Thelma C. Copiozo, Chairman, Committee on Health, Sanitation, Food and Nutrition, duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to affirm the commitment and willingness of the Municipality of Narvacan, Ilocos Sur as partner of the Department of Health (DOH) in the implementation of the Family Planning Program for the benefit of the community in particular and the country in general;
