**RESOLUTION ALLOCATING FUNDS FOR MUNICIPAL DEVELOPMENT PROJECTS IN THE AMOUNT OF FORTY MILLION NINE HUNDRED THIRTY SEVEN THOUSAND TWO HUNDRED THREE PESOS (P40,937,203.00) REPRESENTING THE DIRECT SHARE OF THE MUNICIPALITY OF NARVACAN FROM THE TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT 7171**

**WHEREAS**, the Municipal Administration has identified priority projects to sustain its development efforts thereby strengthening the economy of the municipality;

**WHEREAS**, the Members of the Sangguniang Bayan fully support the development agenda of the Municipal Administration;


**RESOLVED FURTHER** to enact the corresponding appropriation ordinance, to wit:




