RESOLUTION AUTHORIZING THE HONORABLE ZURIEL S. ZARAGOZA, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT I (DA-RFU I) AND AGRICULTURE AND FISHERY COUNCIL (AFC) FOR THE CONSTRUCTION AND/OR REHABILITATION/IMPROVEMENT OF RIVADAVIA AND AMBULOGAN FARM-TO-MARKET ROADS

WHEREAS, the Department of Agriculture (DA) is providing integrated services to ensure the increase in farm productivity as well as real-income of small farmers;

WHEREAS, the construction and/or rehabilitation/improvement of Farm-to-Market Roads (FMR) is a project for agricultural development and production;

WHEREAS, the Department of Budget and Management (DBM) issued to Department of Agriculture (DA) a Special Allotment Release Order (SARO) which will be made available for expenditure in relation to the implementation of various agricultural projects;

WHEREAS, the Local Government Code of 1991 allows the national agency to complement national funded requests, facilities, programs and services jointly or with the assistance of the local government units;

WHEREAS, the Local Government Unit of Narvacan has identified the sites and requested the release of fund for the construction and/or rehabilitation/improvement of Rivadavia and Ambulogan Farm-to-Market Roads;

WHEREAS, cognizant of the Agriculture and Fishery Council's (AFC) potential as partners in development that would provide private sector views and inputs, the Department of Agriculture (DA) Secretary issued Special Order No. 542, Series of 2007 authorizing the AFC to monitor and validate DA programs and projects;

WHEREAS, the available fund for the construction and/or improvement/rehabilitation of Farm-to-Market Roads (FMRs) in LGU-Narvacan has a total amount of FIVE MILLION PESOS (P5,000,000.00) for the following projects:



PERDIDO**, Ph.D. and to the AFC represented by its Chairman **MR. VINCENT A. ADORNA** to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the Memorandum of Agreement (MOA).
