RESOLUTION AUTHORIZING THE HONORABLE ZURIEL S. ZARAGOZA, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT I (DA-RFU I) FOR THE ESTABLISHMENT OF SCREENHOUSE FOR THE PRODUCTION OF QUALITY OFF-SEASON HIGH VALUE CROPS

WHEREAS, one of the objectives of the Agriculture and Fisheries Modernization Act of 1997 is to fulfill the country's food security requirements;

WHEREAS, the Agri-Pinoy High Value Crops Development Program of the Department of Agriculture provides the national directions and framework for harmonizing local initiatives;

WHEREAS, to ensure that the program implementation will redound to the advantage of the vegetable farmers, the DA-RFU I is encouraging Local Government Units (LGUs) to propose for the development of agricultural project on a counter-parting scheme;

WHEREAS, the DA-RFU I has allotted funds for the establishment of Screenhouse for the production of quality off-season high value crops;

WHEREAS, the Local Government Unit of Narvacan is qualified as the recipient of the said facility and has the capability to manage its production and marketing of high value crops produced inside the established screenhouse;

WHEREAS, the DA-RFU I shall transfer to the LGU-Narvacan the amount of One Hundred Thousand Pesos (P100,000.00) for the establishment of one (1) unit screenhouse;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the **Honorable Zuriel S. Zaragoza**, Municipal Mayor, to enter into a Memorandum of Agreement (MOA) with the Department of Agriculture Regional Field Unit I (DA-RFU I) for the establishment of screenhouse for the production of quality off-season high value crops;

RESOLVED FURTHER that a copy of this Resolution be forwarded to the DA – RFU I, represented by its OIC-Regional Executive Director **VALENTINO C. PERDIDO** to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the Memorandum of Agreement (MOA).




