RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HOME DEVELOPMENT MUTUAL FUND FOR THE IMPLEMENTATION OF REPUBLIC ACT 9679 OR THE HOME DEVELOPMENT MUTUAL FUND LAW OF 2009

WHEREAS, Republic Act No. 9679, otherwise known as the Home Development Mutual Fund Law of 2009 enunciates that it is the policy of the State to establish, develop, promote and integrate a nationwide sound and viable tax-exempt mutual provident savings system suitable to the needs of the employed and other earning groups, and to motivate them to better plan and provide for their housing needs, by membership in the Development Mutual Fund, with mandatory contributory support of the employers in the spirit of social justice and the pursuit of national development;

WHEREAS, the Pag-IBIG Fund, created under RA 9679, is mandated to implement the provisions of the Home Development Mutual Fund Law of 2009 to achieve the objectives of improving the quality of life of the Filipino workers by providing them with sufficient shelter and an integrated nationwide provident savings system;

WHEREAS, the Local Government Unit of Narvacan is guided with the objective of promoting welfare and sustainable economic development and growth of the municipality through industrial peace and harmonious labor-management relationship;

WHEREAS, the Pag-IBIG Fund and LGU of Narvacan agree to cooperate and assist each other in the enforcement of the SSS, GSIS and Pag-IBIG Fund coverage;


WHEREAS, the LGU of Narvacan has signified its willingness and commitment to give its full support in the implementation of RA 9679 or the Home Development Mutual Fund Law of 2009;

NOW THEREFORE, for and in consideration of the foregoing premises, the Sangguniang Bayan of Narvacan, Ilocos Sur, **RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor Zuriel S. Zaragoza to enter into a Memorandum of Agreement with the Home Development Mutual Fund for the implementation of Republic Act 9679 or the Home Development Mutual Fund Law of 2009;

RESOLVED FURTHER that a copy of this Resolution be forwarded to the Home Development Mutual Fund, represented by the Area Head of the NL Provident and Technical Support Group, San Fernando City La Union, MS. LILIA M. ANGULUAN, to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the Memorandum of Agreement (MOA).
