RESOLUTION EARNESTLY REQUESTING THE HON. CORAZON "DINKY" J. SOLIMAN, SECRETARY, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), TO EXPAND THE 4 Ps (PANTAWID PAMILYANG PILIPINO PROGRAM) IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the Paritawid Parillyang Pilipino Program (Paritawid Parillya) has been developed as a poverty reduction measure that provides conditional cash transfer to extreme poor households to meet certain human development goals set by the Government;

WHEREAS, the Department of Social Welfare and Development (DSWD) was tasked to lead in the implementation of this program and to coordinate with the other Government Agencies, the Local Government Units and the Non-Government Organizations to ensure effective implementation;

WHEREAS, the Local Government Unit of Narvacan has been identified as site for the implementation of the program;

WHEREAS, the barangays of Narvacan identified additional indigent families and recommended them to the Sangguniang Bayan as beneficiaries of the program;

NOW THEREFORE, the Sangguniang Bayan of Narvacan, in session assembled and on motion duly seconded, **RESOLVED AS IT IS HEREBY RESOLVED** to request the **Hon. Corazon "Dinky" J. Soliman,** Secretary, Department of Social Welfare and Development (DSWD), to expand the 4 Ps (Pantawid Pamilyang Pilipino Program) in the municipality of Narvacan, Ilocos Sur;

RESOLVED FURTHER that copies of this Resolution be forwarded to the **Hon. Corazon "Dinky" J. Soliman** and to all agencies and parties concerned for their kind information and appropriate actions.
