RESOLUTION ABOLISHING SIX (6) POSITIONS AND CREATING FOUR (4) NEW POSITIONS IN THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR

WHEREAS, it is the policy of the Municipality to determine the offices, positions and salaries for the proper conduct of programs, projects, services and activities of the Municipal Government;

WHEREAS, for the judicious improvement of services to the people, six (6) positions are abolished and four (4) new positions are created;

WHEREAS, the abolished positions are:

1. *Community Affairs Officer III* – SG 18, under the Office of the Municipal Mayor with annual salary of Two Hundred Eighty Eight Thousand Seven Hundred Eight Pesos (P 288,708.00);
2. *Administrative Aide I* – SG 1, under the Office of the Municipal Mayor with annual salary of Eighty Four Thousand Five Hundred Twenty Eight Pesos (P 84,528.00);
3. *Administrative Aide I* – SG 1, under the Market Enterprise Office with annual salary of Eighty Four Thousand Five Hundred Twenty Eight Pesos (P 84,528.00);
4. *Revenue Collection Clerk I* – SG 5, under the Office of the Municipal Treasurer with annual salary of One Hundred Thirteen Thousand Six Hundred Seventy Six Pesos (P 113,676.00);
5. *Administrative Assistant VI* – SG 12, under the Office of the Municipal Mayor with annual salary of One Hundred Eighty Six Thousand Nine Hundred Ninety Six Pesos (P 186,996.00);
6. *Security Agent I* – SG 8, under the Market Enterprise Office with annual salary of One Hundred Forty One Thousand Ninety Six Pesos (P 141,096.00);

WHEREAS, the newly-created positions are:

1.Environmental Management Specialist II – SG 15, New Item, under the Office of the Municipal Mayor with annual salary of Two Hundred Thirty One Thousand Four Hundred Twenty Pesos (P 231,420.00);

2.Education Research Assistant II – SG 10, New Item, under Municipal Agriculture Office with annual salary of One Hundred Sixty Two Thousand Six Hundred Seventy Two Pesos (P 162,672.00);

3.Medical Technologist II – SG 15, New Item, under the Office of the Municipal Health Officer with annual salary of Two Hundred Seventy Two Thousand Two Hundred Fifty Six Pesos (P 272,256.00);


4.Midwife II – SG 11, New Item, under the Office of the Municipal Health Officer with annual salary of Two Hundred Five Thousand One Hundred Eighty Eight Pesos (P 205,188.00);



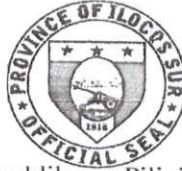
