**RESOLUTION EARNESTLY REQUESTING THE HON. ROGELIO SINGSON, SECRETARY, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) THRU ENGR. RODOLFO DION, DISTRICT ENGINEER OF THE 2<sup>ND</sup> DISTRICT OF ILOCOS SUR TO PROVIDE FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY FIVE MILLION PESOS (35,000,000.00) FOR THE RECONSTRUCTION AND REHABILITATION OF INFRASTRUCTURES LIKE ROADS, BRIDGES AND SEAWALLS/FLOOD CONTROL STRUCTURES HEAVILY DAMAGED BY TYPHOON 'MARING' IN THIS MUNICIPALITY**

**WHEREAS**, the onslaught of typhoon '**MARING**' accompanied by heavy rains has brought severe damage to infrastructures like roads, seawalls and bridges in our Municipality;

**WHEREAS**, the Sangguniang Bayan with the approval of the Municipal Mayor has passed a Resolution declaring the Municipality of Narvacan under a '**STATE OF CALAMITY**';


