RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY BENIGNO SIMEON C. AQUINO III, PRESIDENT, REPUBLIC OF THE PHILIPPINES, THRU THE HON. PAQUITO N. OCHOA, JR., EXECUTIVE SECRETARY, TO ALLOCATE FUNDS IN THE AMOUNT OF FIFTY MILLION PESOS (P 50,000,000.00) FOR THE CONCRETING/IMPROVEMENT OF VARIOUS FARM-TO-MARKET ROADS AT NARVACAN, ILOCOS SUR

WHEREAS, the Municipal Administration has placed on top of its development agenda the concreting/improvement of various farm-to-market roads at this municipality, this time at barangays Abuor, Cagayungan, Sucoc, Dasay and Sulvec;

WHEREAS, this goal, however is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government;

WHEREAS, the Municipal Administration urgently needs development funds to meet the urgency of the said project which needs a funding requirement of Fifty Million Pesos (P50,000,000.00), the breakdown: Ten Million Pesos (P10,000,000.00) for each of the five abovementioned barangays;

WHEREAS, when fully realized, the said project will provide better and faster means of transporting farm products to the market and will promote inter-trade relations with the neighboring barangays, thereby enhancing economic growth and development of the whole community;




