RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE RURAL HEALTH UNIT (RHU) FOR THE CREATION AND MAINTENANCE OF A PER FAMILY PAYMENT RATE (PFPR), CAPITATION, TB DOTS PACKAGE, MATERNITY CLINIC PACKAGE, NEWBORN SCREENING AND ANIMAL BITE PACKAGE PHILHEALTH TRUST FUND

WHEREAS, the Rural Health Unit (RHU) is committed to providing free and accessible health services to all Narvacaneos, particularly the underprivileged members of the community who are in urgent need of health care and medicines;

WHEREAS, the RHU is a trusted partner of LGU-Narvacan in ensuring the health and well-being of its constituents, pursuant to the general welfare clause of the Local Government Code of 1991;

WHEREAS, the funds allocated to the RHU devolve upon the general fund of LGU-Narvacan. However, to facilitate the efficient delivery of quality health services, there is a need to direct such funds for the benefit of the RHU to a Trust Fund, to be created for specific purposes;

WHEREAS, the Philippine Health Insurance Corporation (PhilHealth) has agreed to release to LGU-Narvacan the proceeds of the Primary Care Benefit I (PCB I) Package, requiring the creation and maintenance of a Per Family Payment Rate (PFPR), Capitation, TB DOTS, Maternity Clinic Package, Newborn Screening, and Animal Bite Package Trust Fund;


NOW THEREFORE, for and in consideration of the foregoing premises, the Sangguniang Bayan of Narvacan, Ilocos Sur, **RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor Zuriel S. Zaragoza to enter into a Memorandum of Agreement with the Rural Health Unit (RHU) for the creation and maintenance of a Per Family Payment Rate (PFPR), Capitation, TB DOTS Package, Maternity Clinic Package, Newborn Screening, and Animal Bite Package Trust Fund. The MOA stipulates that LGU-Narvacan shall create and maintain a PPHILHEALTH Trust Fund for the exclusive use and benefit of the RHU. The PHILHEALTH Trust Fund shall form part of the proceeds of the Primary Care Benefit I (PCB I) Package to be released by PhilHealth to the RHU for distribution to duly qualified indigent residents of the Municipality of Narvacan;

RESOLVED FURTHER that the PHILHEALTH Trust Fund shall only be used exclusively for the purposes stated in the MOA;

RESOLVED FINALLY that copies of this Resolution be forwarded to all persons and parties concerned for their information and appropriate action.


