**RESOLUTION AMENDING THE ITEM ON "TOURISM DEVELOPMENT – PROVISION OF STREETLIGHTS" IN RESOLUTION NO. 30-C, SERIES OF 2017/ APPROPRIATION ORDINANCE NO. 11-C**

**WHEREAS**, this august body has previously passed Resolution No. 30, series of 2017 with a corresponding list of projects to be implemented in accordance with Republic Act No. 8240.

**WHEREAS**, as per directive of the Department of Budget and Management – Regional Office I (DBM-ROI), specification of the projects covered under "Tourism Development – Provision of Streetlights" needs to be carried out in order to effectively implement the provisions of R.A. 8240.

**WHEREAS**, the proposed amendment is consistent with, and is mandated by the pertinent DBM rules and regulations prescribing the release and utilization of shares of LGUs from the collections of native tobacco excise tax pursuant to R.A. 8240.

**WHEREAS**, the improvement of roads going to declared tourism zones will greatly promote the beautification of our local tourist attractions, make them more accessible to tourists, and will further ensure the safety and convenience of tourists visiting our town.

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to amend the item on "Tourism Development – Provision of Streetlights" in Resolution No. 30-C, Series of 2017/ Appropriation Ordinance No. 11-C to read as follows:




