RESOLUTION REVISING THE ALLOCATION ON THE DIRECT SHARE OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR UNDER RESOLUTION NO. 30 FROM THE COLLECTIONS OF EXCISE TAX ON LOCALLY MANUFACTURED BURLEY AND NATIVE TOBACCO CIGARETTES UNDER RA NO. 8240 FROM FY 2014 AMOUNTING EIGHTY MILLION TWENTY SIX THOUSAND NINE HUNDRED NINETY FIVE PESOS (80,026,995.00)

WHEREAS, this august body has previously passed Resolution No. 30, series of 2017 with a corresponding list of projects to be implemented in accordance with Republic Act No. 8240;

WHEREAS, the Municipal Government of Narvacan has found it necessary to carry out a re-adjustment in the allocation of R.A. 8240 funds to specifically apportion the amounts chargeable against FY 2014 to better address the immediate needs and concerns of every tobacco farmer in the different barangays of the municipality purposely for : a) Farm Equipments, Diesel & Electric Pumps/Tractors/Kuligligs/Sprayer/ Mechanical Corn Planter, b) Financial Assistance/Livelihood Projects/Small Scale, c) Continuation of Narvacan RHU and d) Improvement/Concreting of Roads and Bridges;

WHEREAS, this revision would be more in keeping with the guidelines set forth under Local Budget Memorandum No. 76 from the Department of Budget and Management which shall be exclusively utilized for programs laid out under RA 8240, as Amended by RA No. 10351;

WHEREAS, the programs and projects to be implemented under the revised list are also included in the approved Annual Investment Program of the Municipality of Narvacan, Ilocos Sur;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to appropriate the amount of **EIGHTY MILLION TWENTY SIX THOUSAND NINE HUNDRED NINETY FIVE PESOS (80,026,995.00)** representing the Direct Share of the Municipality of Narvacan, Ilocos Sur from the collection of Burley and Native Tobacco Pursuant to RA No. 8240, as Amended by RA No. 10351 from FY 2014.
